Placement of Funds:

- 1. Collected Funds will be placed in the Laramie County 4-H or WY State 4-H Foundation operating fund under a special budget line titled Maxine M. Epler 4-H Memorial Fund.
- 2. These funds must be maintained by Laramie County 4-H and shall be used only for the purposes listed below.
- 3. The Laramie County 4-H Program will pay loan amounts to qualifying 4-H member(s) and collect principal and interest at the termination of the loan(s).

Use of Funds:

- 1. These funds will be used to provide loans for 4-H members to buy beef, sheep, and swine animals for 4-H projects.
- 2. Loan Details:
 - a. \$1000 to loan. Two or more loans will be made.
 - b. Maximum loan amounts will be \$500 or the animal's market price whichever is the smallest amount.
 - c. Loan length will be one 4-H year (October 1st through September 30th).
 - d. 4-H member will pay the Prime Interest Rate as of Oct. 1st of the current 4-H year, currently 3.25% A.P.R., on the principal for the length of the loan.
 - e. To obtain a loan 4-Hers must complete the Maxine M. Epler 4-H Memorial Fund Application Form. (See Attached form)
 - f. Completed application forms will be accepted throughout the 4-H year until all funds have been loaned out.
 - g. All loans are due back by Sept. 30 of the current 4-H year that the loan was awarded.
- 3. If possible, a member of the Maxine Epler family will review the applications and give input into the awarding of the loan(s).
