4H plans to continue through zoom meetings during the COVID-19 shutdowns. State has said that we cannot do any face to face meetings until 5/15. We need to find a balance between online schooling and other online learning so that kids do not get burned out.

So far Amber has not heard that WY will be canceling any fairs, although other states have already canceled theirs. We should all be proactive about different possibilities and ideas. Start thinking of the economics of things if the fair is canceled. Could we do a virtual sale or break-even event. If you have ideas take them to the Fairboard.

Tagging is a concern if we are not able to do it in person. How would we tag animals? Ideas were discussed for handing out tags and requiring the members to submit a picture of the tag in the animal's ear. Tamara will ask the Fairboard at their next meeting what their thoughts were on this.

It was suggested that we have separate group discussions about these different concerns and the possible resolutions.

Erin stated that she had received an email on Saturday regarding the Bleachers noting that the shipping had been delayed. They will call when they have been shipped. She has ok'd the delivery with Tom at the fairgrounds. We will have a plaque made for them later on. It was discussed how we would like to install them and decided that we will look into pouring cement and making them permanent so that they won't be moved around. It will have to be noted to Tom that they will only be used for 4H and Fair.

The 4H carnival will be canceled for now. It will be added to next months agenda to decided if it should be canceled for the year or postponed for a later time, possibly during 4H week.

The School has extended the scholarship deadlines to 4/15. Amber will get info out to members by 4/17
